Privacy Policy

Scope

Collection of Personal Information

How we collect information

Ebara collects a range of personal information dependent upon your interaction with us. Examples of how Information that is collected directly from you includes if you:

- Make a product complaint
- Lodge a warranty enquiry
- Order a product

Type of information collected

Information collected may include but is not limited to your name, address, contact details such as phone number, address, and email address. Credit Reporting Information

Ebara may source financial and trading information from third parties such as trade referees supplied by you or from a credit reporting agency. This information is securely held for internal accounting and administration purposes connected with Ebara's business functions.

Disclosure, Use & Storage

Disclosure

Your information may be disclosed from time to time to people within the company on a "need to know" basis to ensure our business functions are carried out smoothly or enhance our operations. Use

Ebara uses your information to enhance our business functions which can include:

Storage

The security of your personal information is important to us. Ebara takes all reasonable technical and procedural steps to protect your personal information from accidental or unlawful destruction, and accidental loss. Ebara will ensure your personal information is protected from misuse, interference, loss and from unauthorized access, modification or disclosure. We will endeavour to destroy or de-identify your personal information when it is no longer required, subject to our legal obligations.

Rights

You have the right to access and correct any personal information held about you by sending a request by email to the compliance manager who will respond to that request within a reasonable time frame (usually 30 days). Whilst we take all reasonable steps to ensure that your personal information is accurate and up to date, we appreciate any assistance from you if your circumstances change, or if you feel that the personal information we hold may be incorrect.

Access by others

Ebara will only issue your personal information to others not involved in our business functions if:

- We have a legal obligation to do so
- You expressly provide permission for us to do so
